Madam/Dear Sir,


In reference to University Notification No. Admission/25/404-503 dated: 20/06/2025, the matter has been examined in detail from the examination point of view. It is hereby re-stressed that the admission or promotion to Semester V (NEP) be permitted by the respective Principal only after confirming the eligibility of each student in accordance with the academic standards.

As you are aware, students receive mark sheets specific to each semester instead of consolidated results. Due to a recent modification in the eligibility criteria, the software logic must be revised in line with the notification, which includes testing the new eligibility requirements as well as additional criteria that need to be verified for students in other semesters and programs. Given that the Notification was issued mid-session and the admissions process is already in progress, the eligibility conditions outlined in the Notification will be temporarily inaccessible in the software in that form.

In light of this and as explained in detail to the participating Principals in the meeting also, the relevant college is advised to admit only those students into the V semester who have met the eligibility based on the credits obtained and other criteria as stipulated in the statutes. An Eligibility Verification Certificate, duly signed by the respective Principal confirming the eligibility, should be included with the submission of the Registration Return for the aforementioned students as per Annexure-A, on the above lines.
